Councillor P Barrett confirmed he will submit paid bills for £2500 to Powys County Council to reclaim the outlay.

**Knighton Church in Wales's Governor**

The Chair confirmed he had contacted the Chairman of Governors at Knighton School making it known that the Community of Beguildy should have one representative on the board which she agreed with.

#### **Asset Transfer of land at Knucklas Community Centre**

The Chairman confirmed that there was still outstanding issues in relation to the boundary responsibility, the car park, the play area together with the playing field. The Chairman confirmed that a meeting to discuss these issues has been arranged with Powys County Council on Friday 17<sup>th</sup> April.

#### **5428 COUNTY COUNCILLOR'S REPORT.**

County Councillor John Brunt addressed the Council on various topics.

He gave advice on the new purchasing system in use by Powys County Council as it may affect business between the Community Council and the County Council.

He reported on the reasons why the refuse and recycling vehicles did not collect from properties on U1162 and the situation regarding recycling of Tetrapac type containers.

He explained the payment system to local communities for the management of recycling bring sites, such as the one at Knucklas Community Centre.

He gave details of the road closure in Knucklas, to facilitate a new water main, due to take place in June and the arrangements which would be in place to ensure access to residential properties while the work was carried out.

He advised the Council on whom to contact with regard to the encroachment on the roadside verge on the B4355.

He gave an update on the Community Asset Transfer at Knucklas and explained the reasons for the delay in the proceedings. He gave details of a meeting he had arranged for Friday 17<sup>th</sup> April when the Chairman of the Community Council and the Chairperson of the Knucklas Community Centre Management Committee would have the opportunity to address their concerns with a number of officers from Powys County Council.
